## CONDINTIONS:

1. Only down wood may be cut.
2. No young trees or spouts may be damaged.
3. All brush and tree limbs must be piled in compliance with the Board of Public Works brush chipping policy.
4. **SHARP PARK** - Only select trees that will be determined by the Parks, Recreation & Forestry Director may be removed.
5. Cutting of unauthorized wood is ground for revocation of this permit and prosecution.
6. ATV's and lawn tractors are permissible with trailer to haul firewood. No other motorized vehicles are allowed. No motorized vehicles are allowed in Sharp Park.
7. City of Oconto may immediately cancel or revoke this permit for any reason by giving oral notice to the permittee.
8. Permittee must follow all applicable City of Oconto Parks, Recreation & Forestry Rules and regulations.
9. Permittee will use the wood for himself/herself and shall not sell the wood.
10. Permittee indemnifies and holds harmless the City of Oconto from all claims, damages or liability resulting from any action or inaction of the permittee, its employees or agents.
11. This permit will expire 10 days after permit was issued or 5 cords cut.
12. Permittee must carry Firewood Permit with them when obtaining wood.

SALVAGE OF FIREWOOD  
FROM CITY OF OCONTO LANDS

City of Oconto will permit salvage of firewood for private use from the City of Oconto under the following conditions:

1. Any person who wishes to salvage firewood on the City owned park requires a permit.
2. Firewood permits are restricted to residents and/or landowners of the City of Oconto. Firewood taken for personal use only and is not to be sold.
3. No more than 5 standard cords (4'x 4' x 8') per household, per year may be cut.
4. Anyone found cutting or removing firewood or other forest products outside of the designated areas is subject to arrest for timber theft.

Fines up to \$5,000.00 or imprisonment up to 5 years or both may be assessed against anyone for timber theft.
